Hello Cheryl,

I would like to speak please at the NWLA meeting on Thursday 13 Feb on Agenda Item 11: North London Heat and Power Station Update.

A brief outline of my deputation is as follows:

Islington Environmental Alliance's deputation is to ask you, as the governing body of the North London Heat and Power Project, to commission an Independent Project Review (IPR) ('cold eyes review') of the NLHPP Project, especially the new Energy Recovery Facility, undertaken by a party external to the NLWA and its partners. This Independent Project Review is essential to:

- provide you with transparency of the project's progress against plan, likely outturn cost and completion timescale
- ensure you are fully informed for the decisions you will need to make to achieve the best outcomes for the project.

The cost of such a review is small, as it only involves 3 reviewers, takes 3 to 5 days and focuses on interviewing the key members of the project team. They are common best practice for large infrastructure projects, such as in HM Treasury's Three Lines of Defence assurance framework.

I live in Archway so it would suit me to attend the meeting in person at Camden's offices. Please let me know what time I need to be there.
